Feb. banging on walls, doors, windows, other objects, throwing self on floor. 1 PROPERTY DAMAGE - Deliberately breaking, defacing or destroying things by hitting, tearing or cutting, throwing, burning, marking or 2 scratching. 3 PHYSICAL ASSAULT - Causing physical pain to other people or to animals by hitting, kicking, biting, pinching, scratching, pulling hair 4 or striking with an object. 5 6 DISRUPTION - Interfering significantly with activities of others by clinging, pestering or teasing, arguing or complaining, picking fights, laughing or crying without reason, interrupting, yelling or screaming. 7 8 VERBAL / GESTURAL ABUSE - Swearing, verbal threats, name-calling, obscene gestures, gestures that indicate aggressive intent or 9 threat. 10 11 SELF-INJURY - Causing injury to own body by hitting self; banging head; scratching, cutting or puncturing, biting, rubbing skin (removing scabs); pulling out hair; picking on skin; biting nails (causing bleeding or biting down to the guick, includes cuticles as well) or 12 pinching.
